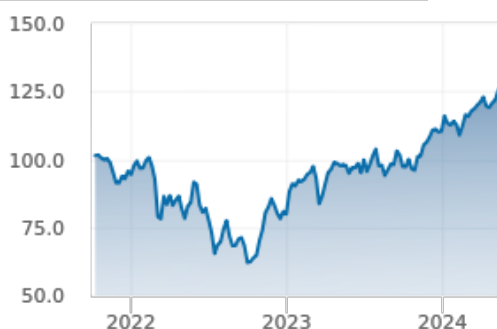
DESCRIPTION
